Men hijack van with Rs 2 crore in cash, later abandon robbery bid

ROBBERS HIJACKED a van on Friday morning soon after it was loaded with Rs 2.13 crore in cash from a branch of the State Bank of India (SBI) at Gandhidham of India (SBI) at Gandhidham town in Kutch but abandoned the webicle on National Highway 41 after a hot pursuit by police personnel and private cash handling agency staffers, to whom the van belonged.

The incident took place around 11 am at Swami Vivekanand Circle, which is also known as Banking Circle due the large number of banks there. The police said that after loading the

said that after loading the cash in the van, the staff of the private agency decided to have breakfast near the bank itself.

"While the agency staffers
were having breakfast, a man ap-
